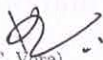
- (1) Proposal for the academic year 2024-25 has been submitted by Asian Global School, Opp. Param – 22, TP No.44, Chandkheda, Ahmedabad – 382 424 run by CIP Foundation, for Nursery, Jr.KG, Sr.KG, Primary Section (Std.1 to 8), Secondary Section (Std.9th & 10th) and Higher Secondary Section (Std.11th & 12th) (General & Science) (CBSE – English Medium) along with relevant documents.
- (2) FRC has considered provisional order dtd. 19.02.2026 passed by the FRC for the academic year 2026-27 for Nursery, Jr.KG, Sr.KG, Primary Section (Std.1 to 8), Secondary Section (Std.9th & 10th) and Higher Secondary Section (Std.11th & 12th) (General & Science) (CBSE – English Medium).
- (3) Objections raised by the School vide its Letter dated 02.03.2026.
- (4) Notice issued to remain present for hearing on 10-06-2026.
- (5) Documents submitted by the School on dated: 10-06-2026.

- (1) Asian Global School, Opp. Param – 22, TP No.44, Chandkheda, Ahmedabad – 382 424, run by CIP Foundation, for Nursery, Jr.KG, Sr.KG, Primary Section (Std.1 to 8), Secondary Section (Std.9th & 10th) and Higher Secondary Section (Std.11th & 12th) (General & Science) (CBSE – English Medium) along with relevant documents. We have gone through the papers submitted along with proposal. It appears that the school has produced audit report for the years: 2023-24 & 2024-25. The School has also produced Provisional Income & Expenditure Account Statement

for the period from 01.04.2025 to 30.09.2025 and projected Income & Expenditure Account Statement for the years: 2026-27 & 2027-28. It appears that the strength of students is 1616.

(2) Considering the above referred proposal the FRC has issued a notice for personal hearing of dated 10.06.2026. In response of the notice, the Ld. representatives of school Shree Chandrakant J. Patel (Trustee) and Shree Avani Ramaiya (Accountant) remained present before FRC, and also additional documents like Bank Statement for the period from 01.04-2025 to 31.03.2026, audit report for the A.Y: 2024-25 & 2025-26, projected Income & Expenditure Account Statement for the A.Y: 2026-27, Rent Agreement and requested to grant increases in the provisional fees as proposed by school.

During personal hearing Ld. representative of the school requested to determine fees of Rs.68,000/- for the standard Nursery, Jr.KG & Sr.KG and fees of Rs.90,000/- for the standard 1 to 10.

(3) The FRC has considered income & Expenditure account statement for the A.Y: 2023-24 & 2024-25 and other document. After gone through the written as well as oral submission of the school management at the time of hearing and looking to the Expenditure for the A.Y: 2025-26, the school has claimed expenditure under the heads like School Advertisement Exp., Communication & Marketing Exp., Staff Picnic Exp., Staff Welfare Exp., Activity Exp., Consultancy Exp. and School Function Exp. etc. are either higher sides and or not justifiable because they are without explanation and not for education purpose and Some of the Expenditure are for the Optional Activities. There for considering the students strength and also considering reasonable revenue surplus for the purpose of development, education and Expansion of the school and location of the school and request with regard to the fees put forth by the school management, the FRC is of the view that reasonable fees is required to be determined.

(4) FRC has considered section 10(3) of "The Gujarat self-financed schools (Regulation of fees) Act. 2017", which is reproduced as under.

The fee regulatory committee shall determine the total fees which shall be levied by considering all different fees charged by the school.

(5) The FRC is required to exercise the power conferred upon it in a very balanced manner so as to see that on one hand the school management is not deprived of the legitimate fees to be charged from the students and the students also should not suffer by paying exorbitant fees charged by the Self-Financed School. The object

of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017 is to prevent “profiteering” which is defined in Section – 2 (r).

(6) After gone through the documents like receipts & payments statements and other documents submitted by the school, the FRC has determined final fees for smooth running of the school as against the fees proposed by the school, in shown in below table for the A.Y: 2026-27 for Nursery, Jr.KG, Sr.KG, Primary Section (Std.1 to 8), Secondary Section (Std.9th & 10th) and Higher Secondary Section (Std.11th & 12th) (General & Science) (CBSE – English Medium) are as under.

- ♦ The School is directed to charge this determined fees according to the definition of fee or fee structure given in section 2(g) of the Gujarat Self-financed schools (Regulation of fees) Act.-2017. In view of the order passed by Hon'ble Supreme Court of India in SLP (Civil) Diary No. (S)17802/2025 on Dtd.: 29.07.2025 the School shall not demand any amount more than that which is fixed by the FRC.

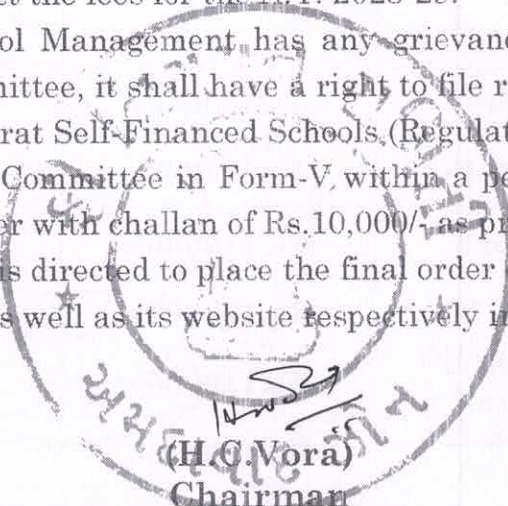
:: Terms and conditions ::

- 1) It is made clear that as per Sub rule (4) of Rule 7 of the Gujarat Self-Financed Schools (Regulation of Fess) Rules, 2017, the FRC has determined the total fees under a single head which may be levied or collected by the school. Therefore the school is permitted to collect fees as per to the definition under section 2(g) of the



Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017 However, total of these fees shall not exceed the total fee determined by the committee as per the above mentioned table.

- 2) The School shall not collect fees amounting to more than one quarter at a time.
- 3) It is also made clear that the school should either return the excess fee collected by the school or give adjustment thereof, in the fees in the next coming academic year without fail.
- 4) Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 5) The Committee has determined the total final fees for academic year: 2026-27 and after giving rise of 5% in the said fees, the school is entitled to collect the fees for the A.Y: 2027-28 and after giving rise of 5% in the fees of A.Y: 2027-28, the school is entitled to collect the fees for the A.Y: 2028-29.
- 6) If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application under Section-12(3) of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017 before the Fee Revision Committee in Form-V, within a period of 21 days from the date of receipt of the order with challan of Rs.10,000/- as process fee.
- 7) The School is directed to place the final order determining the final fees on its notice board as well as its website respectively in Gujarati and English language.
